











What is BACCHUS SME?

BACCHUS SME is a European project launched within the framework of the Erasmus+
programme dealing with vocational education and training.

BACCHUS SME project proposes to develop professional touristic skills in the wine tourism sector. To do so, the European partnership will work together until December 2018.

BACCHUS SME project intends to improve the quality of the services promoted by the small and medium enterprises in the wine tourism industry). The project will develop an analytical tool for organizational diagnosis for the entrepreneurs.

It will support the SMEs in defining their training needs and in elaborating their quality improvement plans. The tool will also facilitate the organizational development of wine tourism SMEs in the viticulture regions of the partnership.

BACCHUS SME 2nd newsletter!

Project partners had a third steering committee meeting on May 8th and 9th 2017 in Plovdiv, Bulgaria.

During this meeting they discussed about the results of IO1 (survey results analysis on wine SMEs Organisational Development) and IO2 (survey results analysis on Wine Tourism Sector. They also prepared work for IO3 (Learning Package and Diagnosis Tool).

After analysing all the presented data (IO1 and IO2 results), partners did a brainstorming session in order to plan the format and contents of the training modules to be developed. They agreed on the following topics:

- wine tourism as wine business opportunities;
- -good models for innovation and how it is connected to entrepreneurial strategy;
- analysis between global and local tourism attractors;
- foreign languages;
- -communication and cooperation techniques;
- wine tourism marketing;
- -ICT applied to wine tourism and digital marketing;
- -wine and heritage;
- -matching wines and food.

Based on the specific needs identified in the research phases, the partnership will develop a diagnosis tool and an innovative blended training course that includes distance learning and face-to-face classes. The course will be tested with several representatives of the wine tourism SMEs. Afterwards, it will be available online on BACCHUS SME project platform.
